EXCHANGES



Secure tenants have the right to exchange tenancies by way of a 'Deed of Assignment'. This can be with the tenant of another local authority and most housing associations.



Before exchanging properties you must gain the written consent of this Council and if the person you wish to exchange with is not our tenant, you will also require the consent of the other landlord. In order for your application to be considered you should complete the form below in full and send this to the Council Offices in Beeston; the full address is given at the bottom of this page.



If the person you wish to exchange with is not our tenant, you may also need to fill in an application form for the other landlord.



We have a maximum of 42 days in which to process your application, but try to deal with this as soon as possible. If and when approved, an appointment will be made for you to complete the 'Deed(s) of Assignment' at one of the Council offices. Again if the person you are exchanging with is not our tenant you will also need to sign similar documents with the other Council or housing association landlord.

We will inspect both your property and the property to which you wish to move, if we own it. Should there be items at your property, which as a result of either your neglect or due to damage, require replacement/repair consent to the exchange will be withheld until the necessary works are completed to our satisfaction.

You should ensure that you are completely satisfied with the standard of cleanliness and decoration of the other property. Additionally, where the other tenant has carried out alterations to the property, such as additional kitchen units, fires, fire surrounds, light fittings, etc. you should establish whether or not these are to be left in place. If they are left you will become responsible for their ongoing repair/ replacement.

Under no circumstances should you exchange properties without having received our written authorisation to do so.

When you have received the authorisation to exchange you should ensure your rent is paid in full to the end of the tenancy, either prior to or at the time you come to sign the 'Deed of Assignment'. If this is not done you may not be allowed to sign until payment has been made.

Grounds for refusal

The grounds for refusing permission for an exchange are legally defined. These are:-

- The Council has been granted possession order by a court against either yourself or the other applicant.
- Possession proceedings have been started by the Council by the issuing of a Notice of Seeking Possession
- The property to which you wish to move is either too large or too small for you and your
- The property in which you wish to move was either built, or has been extensively adapted, for the occupation by a disabled person and your family has no disabled member, who would make use of such facilities.
- One of the properties is in a Sheltered housing scheme for elderly people and the incoming tenant does not qualify for this type of housing.
