NOTICE OF MAKING

**BROXTOWE BOROUGH COUNCIL
(CIVIL ENFORCEMENT OFF-STREET PARKING PLACES)
ORDER 2013**

Notice is hereby given that on the 6th of September 2013 Broxtowe Borough Council made the above Order (“the Order”) under its powers contained in the Road Traffic Regulation Act 1984 as amended and under the Traffic Management Act 2004 as amended and all other enabling powers.

The Order relates to existing off-street parking places and proposed new parking places provided by the Council at the locations listed in the Schedule of Parking Places and Charges below and is intended to come into operation on Monday 21 October 2013 (or as soon as possible thereafter).

The Broxtowe Borough Council (Civil Enforcement Off-Street Parking Places) Order 2010 (“the 2010 Order”) came into force on 5 April 2010 and revoked the Order of 2008 in its entirety. The 2010 Order implemented parking charging and permit-holder parking in the Borough of Broxtowe. It also extended the number and type of parking places available. The Broxtowe Borough Council (Civil Enforcement Off-Street Parking Places) Supplementary Order 2012 (“the 2012 Order”) came into force on 17 February 2012 supplementing the 2010 Order. The 2012 Supplementary order enabled the Council to add some new parking places, revoke and amend the conditions of use of some existing parking places, therefore extending the number and type of off-street parking places available.

The Notice of Proposals to make the Order was published in the Nottingham Evening Post on 11th June 2013. The effect of the Order is as shown in that Notice of Proposals, with no amendments

The Broxtowe Borough Council (Civil Enforcement Off-Street Parking Places) Order 2013 will revoke both the existing Orders. The Broxtowe Borough Council (Civil Enforcement Off-Street Parking Places) Order 2010 (“the 2010 Order”) and The Broxtowe Borough Council (Civil Enforcement Off-Street Parking Places) Supplementary Order 2012 (“the 2012 Order”). The penalty charges for contraventions of the 2013 Order will remain the same as the penalty charges for the previous Orders, as described below.

Proposed Penalty Charges

£70 (£35 where paid within 14 days; £105 if paid after service of charge certificate) For contraventions in relation to parking in loading areas; designated disabled persons bays; a restricted area; a permit bay or a bay not designated for that class of vehicle; for using a vehicle in connection with the sale of goods; and for causing an obstruction. For parking in a permit bay without clearly displaying a valid permit.

£50 (£25 where paid within 14 days; £75 if paid after service of charge certificate) For parking for longer than the maximum period allowed; parking beyond the bay markings; returning to the same parking place on the same day within the specified period; parking when the parking place is closed; parking for a purpose other than that permitted; parking with the engine running where prohibited. For contraventions related to parking charges, including: parking without payment of the parking charge; parking after expiry of the paid time; parking without clear display of the relevant ticket(s), voucher or parking clock; and parking without additional payment(s) to extend the parking stay.

1. Pay and Display Car Parks, Category A: Long Stay

Victoria Street, Oxford Street Eastwood. Albion Street, Derby Street (South), Middle Street, Middle Street (Central) and Station Road (Central) (Former Multi-storey car park site) Beeston.

2. Pay and Display Car Parks, Category A1: Long Stay

Devonshire Avenue, Beeston: permit holders only except Saturday between 8:00am and 6:00pm, with no time limit and a continuous period not exceeding 12 hours and no return within 1 hour. No parking on Sundays.

Permitted Times of Use: Public parking Saturday between 8:00am and 6:00pm with no time limit and a continuous period not exceeding 12 hours on all days. No return within 1 hour and only one free period per day. Permit parking Monday to Friday between 8:00am and 6:00pm. No parking Sunday.

Maximum stay 12 hours
No return within 1 hour
One free period per day

3. Pay and Display Car Parks, Category A2: Long Stay

Cliffe Hill Avenue, Halls Road, Stapleford. Victoria Street, Kimberley. Sun Inn, Eastwood, Derby Street (Middle), Beeston.

Over 1 hour	£1.00p

Permitted Times of Use: Public parking Monday to Saturday between 8:00am and 6:00pm with no time limit and a continuous period not exceeding 12 hours on all days. No return within 1 hour and only one free period per day.

Quarterly parking permit	£125.00p
Annual parking permit	£450.00p

Maximum stay 12 hours
No return within 1 hour
One free period per day

4. Pay and Display Car Parks, Category A3: Short Stay

Chilwell Road, Chilwell, Beeston.

Permitted Times of Use: Public parking Monday to Saturday except bank holidays, but including Good Friday. Limited to 3 hours maximum and no return within 1 hour between 8:00am and 6:00pm and only one free period per day.

Maximum stay 3 hours
No return within 1 hour
One free period per day

5. Pay and Display Car Parks, Category B: Short Stay

Foster Avenue, City Road, Portland Street (as amended), Regent Street, Beeston. Eatons Road and Victoria Street, Stapleford. Scargill Walk and King Street, Eastwood.

Permitted Times of Use: Public parking Monday to Saturday except bank holidays, but including Good Friday. Limited to 3 hours maximum and no return within 1 hour between 8:00am and 6:00pm and only one free period per day.

Maximum stay 3 hours

6. Zero-Charge Car Parks, Category C: Long Stay

Station Road, Kimberley

Permitted Times of Use: Public parking Monday to Saturday between 8:00am and 6:00pm with no time limit and a continuous period not exceeding 12 hours on all days.

7. Zero-Charge Car Parks, Category C1: Short Stay

Alexandra Street, Eastwood, Newdigate Street and James Street Kimberley.

Permitted Times of Use: Public parking Monday to Saturday except bank holidays, but including Good Friday. Limited to 3 hours maximum and no return same day between 8:00am and 6:00pm.

Waiting Period	Charge
Maximum stay 3 hours	No Charge

No return within 1 hour

8. Zero-Charge Car Parks, Category C2: Short Stay

King Georges Park, Bramcote, (as amended)

Permitted Times of Use: Public parking Monday to Friday between 9:00am and 3:00pm limited to 3 hours. No return within 1 hour. Except bank holidays, but including Good Friday.

Waiting Period	Charge
Maximum Stay 3 Hours	No Charge

No return within 1 hour

9. Permit Only Parking Places, Category D : Permit

Derby Street (residents), Foster Avenue (Police permit parking area) Regency Court, Bradley Court, Jessamine Court, Yew Tree Court and The Lilacs (Housing) Hassocks Lane (Fire Station Access Road) Beeston. Victoria Street and Wellington Street (Housing) Eastwood. Rockwell Court (Housing) Stapleford.

Permitted Times of Use: Permit parking Monday to Sunday (inclusive) No time limit and 24 hours on all days.

Permit Parking Only

10. Pay and Display Car Parks, Category H : Long Stay

Station Road, Beeston.

Permitted Times of Use: Public parking Monday to Sunday inclusive daily between 8:00am and 8:00pm with no time limit and a continuous period not to exceed 7 days. Except bank holidays, but including Good Friday.

Brinsley Headstocks, Brinsley. Inham Nook Recreation Ground, Chilwell. Cossall Nature Reserve, Cossall. Colliers Wood, Greasley. Greenhills Road, Eastwood. Hickings Lane Recreation Ground, Ilkeston Road Recreation Ground, Pasture Road Recreation Ground and Queen Elizabeth Park, Stapleford. Greenwood Community Centre and Manor Farm Recreation Ground, Toton. Pit Lane Recreation Ground, Trowell.

Any person wishing to question the validity of the Order (which was made on 6th September 2013) or any of the provisions contained in it on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1984, as amended or on the grounds that any requirement of that Act or any instrument made under it, has not been complied with in relation to the Order may, within six weeks from 6th September 2013, apply to the High Court for this purpose.
