# **NEIGHBOURHOODS AND PLACE SHAPING** is one of the themes that will be covered in the Greater Nottingham Core Strategy.

The Core Strategy will be a set of policies that discuss the key issues facing the area and guide its development up to 2026. It will be a key part of the Local Development Frameworks for Greater Nottingham, the new set of planning policies that will replace each Council's Local Plans.

### About the Neighbourhoods of Greater Nottingham

- Housing supply varies significantly across Greater Nottingham. For example, there is a much higher concentration of owner occupied housing in areas such as Gedling (81%) and Rushcliffe (79%) in comparison with Nottingham City (50%)
- The housing needs of particular groups, including older people, people with disabilities, students and gypsies and travellers need to be met
- There are pressures to intensify housing development in some areas. This can impact on the overall housing mix and have a negative effect on the character of areas
- The need for affordable housing is around 47% of planned new housing supply in Greater Nottingham (this varies from 21% in Nottingham City to 85% in Erewash)
- There is a particular need for affordable housing in rural areas
- The East Midlands has poor design quality for new housing when compared with other regions
- All members of the community need to be able to access jobs, health, housing, education, shops, leisure and community facilities (e.g. community halls, doctors surgeries, etc)
- Good quality health services and the need to create a safer environment are particularly important

### What can we do?

The Core Strategy could require new developments to meet recognised standards such as:

- Building for Life Standards, which are guidelines to improve the design of new developments
- Manual for Streets guidance, which aims to make sure streets are places where people want to live and spend time in
- Lifetime Homes standards, which are guidelines for adaptable homes for everyone

The Core Strategy could also:

- Include targets and requirements for the provision of affordable housing, and consider options for providing affordable housing within rural areas
- Ensure adequate community, sports and recreational facilities are provided
- Encourage accessibility for pedestrians and cyclists in new developments

### Things to think about

- A shortage of suitable and affordable homes can have a negative effect on communities
- Are the houses being built now good enough to meet the expectations of future communities?
- Applying a large number of standards may be seen as being too prescriptive and imposing unreasonable costs on house builders
- Encouraging community facilities to be located close together could help improve their accessibility
