THE ANTI SOCIAL BEHAVIOUR, CRIME AND POLICING ACT 2014

RESTRICTION ON PUBLIC RIGHT OF WAY AT REAR OF MALTHOUSECLOSE/KNAPP AVENUE EASTWOOD 2016

WHEREAS Broxtowe Borough Council ("the Authority") is satisfied that properties adjoining and adjacent to the highway referred to in paragraph 1 of this Order are affected by crime and anti —social behaviour, the existence of the said highway is facilitating the persistent and continuing commission of criminal offences and anti-social behaviour which is having a detrimental effect on the quality of life of those in the locality. It is in all circumstances expedient to make an Order under Section 59 of the Anti-Social Behaviour Crime and Policing Act 2014 ("the Act") for the purposes of reducing crime and anti-social behaviour

NOW THERFORE the Authority in exercise of the powers under Section 59 of the Act, and all other enabling powers, hereby make the following Order: -

- In this Order 'the highway' means the highway specified in Schedule 1 to this Order
- Save as provided in Article 2 of this Order the public right of way over the highway is restricted at all times to all persons so that passage and repassage thereover may not occur.
- 3. Nothing in Article 2 of this Order shall apply to the following:
 - (1) The occupiers or owners of any properties adjoining or adjacent to the highway
 - (2) The Police, Fire and Rescue Service or Emergency Ambulance Services
 - (3) A local authority undertaking a statutory duty

- (4) Any statutory undertaker provider of gas, electricity or water services or communications provider which maintains apparatus in the highway.
- 4. A gate or other barrier may be installed, operated and maintained at any point or points on the highway as determined from time to time by the Authority. The responsible department for the maintaining and operating the gates can be contacted on 0115 9177777.
- The alternative routes available for persons affected by the Order is via Church Street, Knapp Avenue the length of highway to which the public has access (between Knapp Avenue and Plumptre Way).
- 6. This Order shall take effect on the 4 March 2016 for a period of three years.



BROXTOWE BOROUGH COUNCIL MADE A PUBLIC SPACES PROTECTION ORDER USING POWERS ENACTED UNDER SECTION 59 ANTI-SOCIAL BEHAVIOUR CRIME AND POLICING ACT 2014 (THE ACT) ON 4 MARCH 2016 THE ORDER CAME INTO FORCE ON 4 MARCH 2016 WILL BE REVIEWED ON 4 MARCH 2019 AND APPLIES TO THE FOLLOWING DESIGNATED AREA.

DESIGNATED AREA

HIGHWAY AT EASTWOOD IN THE BOROUGH OF BROXTOWE

THE ALLYWAY BETWEEN ITS JUNCTION WITH MALTHOUSE CLOSE AND THE LENGTH OF HIGHWAY TO WHICH THE PUBLIC HAS ACCESS BETWEEN KNAPP AVENUE AND PLUMPTRE WAY

THE EFFECT OF THIS ORDER IS TO RESTRICT THE PUBLIC RIGHT OF WAY WITHIN THE DESIGNATED AREA AT ALL TIMES BY ALL PERSONS EXCEPT THOSE LISTED IN THE ORDER

ALTERNATIVE ROUTES FOR PUBLIC ACCESS ARE VIA CHURCH STREET/KNAPP AVENUE THE LENGTH OF THE HIGHWAY TO WHICH THE PUBLIC HAS ACCESS (BETWEEN KNAPP AVENUE AND PLUMPTREE WAY) AND VISIA VERSA

Failure without reasonable excuse to adhere to the public right of way restriction is a criminal offence under sections 67 of the Act. A person guilty of an offence under this section is liable on summary conviction to a fine not exceeding level 3 on the standard scale. Alternatively a constable or authorised person may issue a fixed penalty notice of up to £100.
