What we can do for you

At Nottinghamshire Victim CARE we recognise people have different needs when trying to cope and recover from their ordeal. You may simply want some help or advice, want to understand more about the criminal justice system or seek specialist help.

Whatever level of support you need, we provide a wide range of holistic services designed specifically to cater for individual needs. These include:

- A dedicated Case Worker to support you for as long as you need
- A service that offers as much time as you need to recover
- Information, advice and guidance
- Signposting and referrals to wider specialist support services
- Interview and drop-in facilities
- Outreach support in safe and accessible locations
- Pop-up and drop-in surgeries in community venues and at events
- Access to a Hardship Fund
- Restorative Justice Interventions
- Local access to help through organisations in your community
- Help for family members who have also been affected

Your right to help and support

Nottinghamshire is a safe place to live, work and visit. Your chances of becoming a victim of crime or antisocial behaviour are low. But for those who are, the effects can be long and painful. Often victims feel traumatised, vulnerable and afraid.

If you have been a victim of crime or antisocial behaviour, we can help. We are Nottinghamshire Victim CARE and our mission is to provide whatever support you need to help you cope and recover from your ordeal.

Our service is FREE, confidential and completely independent. It is open to ALL residents of Nottinghamshire and you don't even have to report your crime to the police to access our service.

We believe every single victim has a right to be heard and their needs looked after. And the law agrees: ALL victims are now entitled to support from criminal justice agencies under a Victims' Code and their needs MUST be considered.

Restorative Justice

Restorative Justice is where victims can meet with or communicate directly with offenders. You will be able to explain the impact the offender's actions have had on you and ask them questions.

For victims, meeting the offender can result in a huge sense of relief, aid recovery and help them move on with their lives. For offenders, it can be very challenging as they are confronted with the personal impact of their crime. Government research suggests that RJ (as it is known) helps victims recover from crime. If you are interested in this approach, Nottinghamshire Victim CARE can help arrange it for you.
