PROPOSED INTRODUCTION OF BROXTOWE BOROUGH COUNCIL TECHNOLOGY DRIVE CIVIL ENFORCEMENT OFF-STREET PARKING PLACES ORDER 2018

Broxtowe Borough Council proposes to consider the introduction of the above Order (“the Proposed Order”) and my purpose in writing to you is to undertake consultation, as required by the Local Authorities’ Traffic Orders (Procedure) (England and Wales) Regulations 1996 (“the 1996 Regulations”).

The Proposed Order relates to an existing off-street parking place provided by the Council at the locations listed in the Notice of Proposals attached to this letter. A Statement of Reasons for the Proposed Order is also attached.

Nottinghamshire County Council applied to the Secretary of State for an Order under Schedule 8 of the Traffic Management Act 2004 designating various areas of the County of Nottinghamshire including the Borough of Broxtowe as civil enforcement areas for parking contraventions. Pursuant to that application, The Civil Enforcement of Parking Contraventions (County of Nottingham) Designation Order 2008 brought civil parking enforcement into force in the relevant areas of the County on 12 May 2008.

Pursuant to the Designation Order, on 21 September 2017 Broxtowe Borough Council Community Safety Committee solved to consult and advertise a new off-street parking places order, The Broxtowe Borough Council (Technology Drive) Off-Street Parking Places Order 2018.

After committee approval the Council with delegated powers resolved to introduce a new parking place order to regulate the parking provisions at the Technology Drive car park to improve fair use for motorists, maintain consistency, improve vehicular turnover, implement compulsory parking charges and permit-holder parking at those parking places listed in the Notice of Proposals and to extend the number of off-street parking places to encompass other land owned/managed by the Council. The Proposed Order will also extend the number and type of parking places available in the Borough of Broxtowe and surrounding areas.

The existing regime of the civil enforcement of parking contraventions will remain in force, but will also apply to parking contraventions related to the above amendments.

The council enclose a copy of the formal Notice of Proposals to make the above Order, together with the Statement of Reasons setting out the reasons why the Council is proposing to make the Order.

In order to give full publicity to the proposals, the Notice of Proposals will be advertised in the Nottingham Evening Post on **16 November 2017** and site notices will be displayed at the relevant parking places. In addition, documents providing full details of the proposal, including the proposed Order, will be available for inspection at the Council's offices, as indicated in the Notice of Proposals.

The Proposed Order will revoke any previous orders at this location only. If you wish to comment on the proposals outlined in this letter I would be pleased to hear from you by 2pm on **14 December 2017**. Otherwise, I will assume that you have no comments at this stage. Due to the large number of organisations involved, I regret that it may not always be practical to respond individually to your reply. On completion of this consultation, if the Council decides to proceed with the promotion of the Proposed Order, the Notice of Making will be published locally as required by the 1996 Regulations and a copy of the said Notice to you. At that time you will have an opportunity to inspect the documents and, if necessary, comment or raise a formal objection.
