

## COUNCIL TAX VALUATION INFORMATION SHEET – 2018/19

The Valuation Office Agency, which is part of the Inland Revenue, has valued all the domestic property in the country. Each property has been placed in one of eight valuation bands which range from A to H and reflect the estimated market value for which the property might reasonably have been sold on the open market on 1 April 1991.

As valuations are based on the price a property may have been sold for on 1 April 1991, any rise or fall in a dwelling's value which results from changes in the housing market will not affect its valuation.

### VALUATION BANDS

Band A – up to £40,000

Band B – over £40,000 and up to £52,000

Band C – over £52,000 and up to £68,000

Band D – over £68,000 and up to £88,000

Band E – over £88,000 and up to £120,000

Band F – over £120,000 and up to £160,000

Band G – over £160,000 and up to £320,000

Band H – over £320,000
