1. Apologies

An apology was received from a resident.

2. Welcome and Introductions

Cllr Jill Owen (Chair of the meeting) introduced herself and welcomed everyone. She introduced councillors from Nottinghamshire County Council (NCC), Broxtowe Borough Council (BBC), Nuthall Parish Council (NPC) and Greasley Parish Council (GPC) as above.

3. Policing

The meeting was advised that a representative from the police was not present. Concern expressed about a spate of burglaries in the Kimberley Road/Millennium Way/Nottingham Road area. Cllr P Owen advised that unfortunately this was also happening in other parts of the Borough. He said that Anna Soubry MP would be meeting with the new Neighbourhood Policing Inspector for Broxtowe very soon. Cllr Owen also added that the Nottinghamshire Police and Crime Commissioner, Paddy Tipping, would be attending a meeting of Broxtowe Borough Council's Community Safety Committee in the autumn and this would provide an opportunity for Borough Councillors to make their concerns known.

4. Development in the Green Belt

Prior to this item, the meeting was advised of a relevant section in the Community Action Team protocol. This was read out:

Where planning applications are discussed, members who are members of the Development Control Committee should be encouraged to listen to the debate in order to be better informed when matters come before committee for determination. It is important for members to refrain from expressing definitive views on the merits of the application in the CAT meeting since that could preclude their taking part in any subsequent determination of the application by the Development Control Committee.

Residents should be reminded that their views will not be formally reported within the planning process and that they will need to respond to the planning officer individually to ensure their views are recorded.

A lengthy discussion took place on a current planning application to extend a factory which makes parts for the aero industry.

5. Future meeting dates
