For the people who are deciding to build on this site, I urge you to take a walk to it and around, absorb and monitor how you feel, it really gives a feeling of well-being that can not be created anywhere else in Brinsley.

It saddens me deeply that Broxtowe Council haven't listened to the people of Brinsley, to consider building on Church Lane and ignore the wishes of the vast majority of residents in Brinsley, is not what I would expect a reasonable authority to do.

I can not understand why they would do this and think they should give residents of Brinsley reasons why they are deciding to ignore our wishes.

Why are our authority considering to build on Church Lane and not Cordy Lane? I think we should be told why?

Thank you for your letter of 19 July. Please accept my apologies for the delay in responding but CPRE Nottinghamshire active members are few in number and not always available and I have needed to consult a colleague who has recently been engaged elsewhere.

As I am sure you know, CPRE takes the view that we need to protect the Green Belt as far as possible. However, we recognise that local planning authorities are under pressure to allocate land for new housing and we should certainly prefer this to be brownfield wherever possible. Where greenfield land is to be removed from the green belt, this often means that difficult decisions must be made.

We certainly think that considerable weight should be given to the opinion of local people. If you can demonstrate that consultations with residents received a high response rate and that a convincing majority of those responding favoured a site, that may help in making your case. Unfortunately, local people do not always get the last word, as planning decisions have to be made in accordance with national guidelines and planning law.

That said, CPRE Nottinghamshire certainly has a great deal of sympathy with the preservation of local heritage features and connections and you may wish to point out that the Local Plan Part 2 documents recognize that steps need to be taken to ensure this.

I understand that the Jobs & Economy Committee of Broxtowe Borough Council met on the 16th July 2018, when the above plan was subject to discussion, and the matter put before Full Council of the authority, two days later, I.e. 18th July 2018.

Contained within the plan is the Church Lane, Brinsley site, and as I understand the justification for inclusion is as follows:-Exceptional circumstances required to amend the Boundary of the Green Belt to allow Residential Development, also included, it says, This allocation has significant Housing & Health objectives with only a Minor Landscape objective disadvantages.

Brinsley Parish Council and the views of the majority of residents do not believe the above comments are fully explanatory, as the disadvantages which the village would experience out weigh any advantages that the plan implies.

The land inquestion has always been of some concern, resulting in many objections to earlier suggestions of development taking place. Although not formerly lodging any planning applications, the land owners have "tested the water " so to speak .

I served as a member of Brinsley Parish Council from 1976 for a number of years in which time the land owner sent me a hand sketched plan showing proposed development he wished to undertake. (I was chairman for around fifteen consecutive years) This item never went any further, I informed the land owner it would not receive any support. The landowner was a former Parish Councillor. Some years later, a property developer attended a meeting of the Parish Council with plans for housing on the Church Lane land. Around sixty residents were in attendance, and so much opposition was voiced, the developer, came to the conclusion that he was wasting his time, the plan going no further. These items were never on any agenda for discussion by Broxtowe Borough Council, which I was a member, for just short of twenty years., serving as Mayor in 1989/90.

A few years ago I had a visit from the landowners who asked me to sign a prepared letter in support of housing development on Church Lane, this I refused to do.

I have given you details as above, which show my opposition to any development on the land in question over a great many years.

As a local, I looked carefully at all issues, and with "local knowledge " I believe acted in the best possible interests of the community of which I was part.

Attached you will find my detailed objections, as to why, I believe that the decision to include the Church Lane site, in preference to the Cordy Lane site within the local plan is the incorrect course to take, especially going against, the views of the Parish Council and the majority of residents of the village of Brinsley.

As Chairman of the D.H. Lawrence Society I would like to add the support of the Society to the position taken by the Steering Group in relation to the potential plan to build 110 houses in the Brinsley Parish.

I have visited both the Church Lane site and the Cordy Lane site and fully appreciate why the Cordy Lane site should be the one supported by the majority of the villagers.

As a young man D.H. Lawrence grew up in Eastwood but enjoyed the freedom of walking in what he called "The Country of my Heart". Lawrence also had direct links to the pit at Brinsley, his father worked there, and it seems to me to be important that the headstocks in the Country Park be protected as they stand and their significance not diminished by the close proximity of new houses. Building on the Church Lane site would inevitably mean that houses encroached too closely to the headstocks and the open area that Lawrence knew so well, and used in his short story "Odour of Chrysanthemums.

Thank you for your letter of 21 October detailing the work of the Brinsley Neighbourhood Plan Steering Group in opposing the threat of housing development on the Greenbelt land around the Brinsley Headstocks.

The countryside around the headstocks, also comprising Vine Cottage (the former home of Lawrence's paternal uncle, James, and James' wife Mary Ellen - or 'Polly' - née Renshaw), is an important and integral part of the landscape in the Eastwood area commemorated in D. H. Lawrence's writings. It is described in some detail in the world-famous short story 'Odour of Chrysanthemums', which Lawrence said captured his childhood's atmosphere. Many of the places in Eastwood that Lawrence knew and wrote about are now either destroyed (e.g. the Congregational Chapel on Albert Street), earmarked for development (e.g. the area in front of the Walker Street house) or closed to the public (The D. H. Lawrence Heritage Centre), so it is extremely important that what little remains of the literary and industrial heritage of the area is safeguarded. I am aware of a proposed housing development at Brinsley, with one site being at the north end of Church Lane in the parish. This particular site is of great landscape significance, both in terms of natural beauty and iconic importance as it forms a significant part of DH Lawrence's 'Country of My Heart'. His father worked at the local pit.

The siting of Brinsley headstocks near the site, in a Country Park, further ties the internationally renowned author into this area. The building of houses would both seriously reduce the environmental quality of the land and completely change the character of DH Lawrence's former literary inspiration.
