I wish to confirm my view that I agree with the alternative proposal for the changes to the boundary of Greasley Parish Council. I do not wish to be moved into part of Eastwood. It is bad enough having to move from the parliamentary constituency of Ashfield and Eastwood back into Broxtowe.

Remaining in Greasley will be the only way to help prevent inappropriate development which is threatening to destroy the open countryside we have on our doorstep. It will also benefit the people of Eastwood, helping to keep the countryside on their doorstep too. As residents of Watnall we are happy to support the alternative parish boundary proposal prepared by Greasley Parish Council. We are also happy to support the proposal put forward by Broxtowe Borough Council. However we strongly object to the proposal put forward by Nuthall Parish Council which would place Watnall within the parish of Nuthall. I have been a resident within Greasley Parish for the past 37 years, and I am TOTALLY OPPOSED to Broxtowe Borough Council's proposed sweeping changes to the current Parish Council's boundaries, as I consider such broad changes to be completely unnecessary. We are writing to object to the proposed Parish/Town Council boundary changes that the Council are planning to implement, which affects our property.

#### **Comments/Support**

We have received a pamphlet from Greasley Parish Council outlining the reasons for their objections to these changes, along with their alternative proposal plan, and we find that their case far outweighs the Council's reasons for this change. We agree with them that your proposals are not minor boundary adjustments to fix anomalies and we wish to support their future objectives.

With your letter, received in June, the accompanying OBJECT chart does not mention the Telford Drive area and therefore is confusing. It does state (at point No 8) moving the Coach Drive/Lindley Street area from Greasley to Eastwood. We assume we are also included in this area so you plan to move the Telford Drive estate as a whole, which is a substantial area of properties and electors and yet is not mentioned in your charts or significant reasons given for the boundary line change. The important factors you take into account for the changes to parish arrangements, as stated in your letter, do not seem to be relevant. Access to all properties in our area are from the estate roads, all in the Greasley Parish. In fact, your proposals appear to be moving an access road already in Greasley into Eastwood. With regard to community cohesions, no properties. From the letter we have received from Broxtowe, we do not see how these boundary changes will have the positive impact on properties and residents in our area. All properties in the whole of the Telford Drive area estate are currently in Greasley and should remain there.

We do not agree that there is more parity with east wood. Our address is new Thorpe and Telford Drive and the surrounding area are closely associated with the

Moorgreen/Beauvale/Newthorpe area which is remaining the Greasley parish and so this makes your proposed new boundary line disjointed, unnecessary and certainly not cohesive. The Greasley Parish Council alternative proposal makes more sense. We reject your proposals and ask that our objection be registered and taken into consideration.

We wish our property to remain in Greasley for the following reasons; We are regular users of Greasley Sports and community Centre and want our council tax to continue to support this essential asset, We are aware of the recent purchase by Bloor Homes, of green belt land adjacent to our property. Greasley Council have pledged to prevent building on this agricultural land which separates Eastwood from Brinsley.

Our fear is that Eastwood and Broxtowe council would not have the same ethical attitude. We have lived in this Parish for more than 50 years and would like it to continue as a successful,well functioning council.

Further to the communication received from Greasley Parish Council, please note that I support Greasley Parish council's alternative proposal to slightly increase the boundary of the parish.

In addition, Nuthall Parish Council have issued a communication proposing that Watnall be absorbed into a new combined parish with Nuthall. Please note that I do not support that proposal.

We agree with the alternative proposal of Greasley Parish Council rather than the Broxtowe Borough Council one, because we have been very happy with the way the Greasley council have been running the parish for the last 30 odd years and we do not want to move to any other parish council.
