Statement of Compliance with Section 61F(5) of the Act

Background

Chetwynd: The Toton & Chilwell Neighbourhood Forum was designated by Broxtowe Borough Council on 9th March 2017. The Decision Notice is available as a pdf file at https://www.broxtowe.gov.uk/media/3066/neighbourhood-forum-decision-notice_redacted.pdf

The lifetime of Neighbourhood Forums is five years, and the current designation will expire on 8th March 2022. However, a Neighbourhood Forum can apply to extend its life for further 5-year periods. The Forum sought approval from its membership at the Annual General Meeting held on 7th October 2021. Unanimous approval was given by the members in support of an application to continue for a further five-year period to ensure the Neighbourhood Plan is 'made' and monitored by the Forum as part of the planning process for the Forum Area.

A draft Neighbourhood Plan was submitted to Broxtowe Borough Council in June 2020 following amendments made after Regulation 14 consultation in 2019. Subsequently a Strategic Environmental Assessment (SEA) was deemed necessary following screening of the Plan in February 2021 by the Council. The final Environmental Report from the SEA process has been made available to the Council, and the Forum is currently making amendments to a small number of policies as recommended by the Environmental Report. Once complete, the revised Plan will be submitted to the Council in order for the statutory Regulation 16 consultation and Independent Examination to take place. Once this process is complete, the final Plan will undergo local referendum seeking approval to adopt the Plan. After which, if approved at referendum, the Plan will be 'made' by the Council.

Although the final timescale for the Plan to be 'made' is yet to be fully determined, it is likely to run beyond the current Forum expiry of 8th March 2022. To see the process through, the Forum will need to be active i.e. re-designated for a further five-year period. The Forum also intends to monitor the progress of the Plan once 'made', including the degree to which the aims and objectives are being realised, and the extent to which relevant policies are being considered by the local planning authority when deciding on planning applications. Only a Neighbourhood Forum can make amendments to the Neighbourhood Plan in future if required, or if circumstances change, before the conclusion of the Plan period in 2040, which cannot be totally foreseen at this time.

To this end, **Chetwynd: The Toton and Chilwell Neighbourhood Forum** wishes to continue with its overarching purpose to promote and improve the social, economic and environmental well-being of the Neighbourhood Area¹ and deliver a 'made' Neighbourhood Plan for the community it represents.

Membership Profile²

Membership is open to all those who live and work (whether for businesses carried on there or otherwise) in **Chetwynd: The Toton and Chilwell Neighbourhood Area**, and to elected Members for the area.

The total membership of the Forum currently stands (as at October 2021) at **740 members**, as summarised in Annex 4. The membership is drawn from different parts of the Neighbourhood Area and from different sections of the community, including:

- Residents from every part of the Area
- People who work in the Area
- 8 ward & county councillors
- Broxtowe's MP, Darren Henry

The nature, spread and composition of the membership meets the necessary legislative requirements for the purposes of seeking designation as it closely reflects the demographic profile of this overwhelmingly residential community. The Forum continues to actively encourage new members to promote inclusivity, and the involvement from all parts of the Area and within all sections of the community. There has been a recent small increase (15) in new members following participation by the Forum at Broxtowe's Big Green Festival at Inham Nook Recreation Ground (September 2021), and also in the lead up to, and after, the recent AGM (October 2021).

The Forum has a written Constitution³ (see Annex 1) which clearly sets out the aims, objectives and governance arrangements for the Forum.

Conclusion

The members of the Neighbourhood Forum are committed to seeing the Neighbourhood Plan for Toton and Chilwell through to adoption and being 'made', that will reflect as far as is practicable the aspirations of the wider community, whilst also conforming with national and local planning policy frameworks.

Constructive working relationships are now well established with officers of Broxtowe Borough Council, and this has provided a positive impetus for taking forward neighbourhood planning in Toton and Chilwell.

The re-designation of the Neighbourhood Forum will continue to provide the formal platform for the community to work together, and in concert with the Council, to plan positively and creatively for the future development of Toton and Chilwell through completion of the Neighbourhood Plan and to see it 'made'.
