**NOTICE IS HEREBY GIVEN** that Broxtowe Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 and Regulations within the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 and all other enabling powers hereby makes the following amendments to the aforementioned parking places order to replace current references to the regulations as shown in the table below. Regulations consolidated by parliamentary approval in association with the new traffic enforcement powers under Part 6 of the Traffic Management Act 2004 available to local authorities outside London.

This Notice will make provision to comply with the new consolidated regulation amendments made by Government which affect the Broxtowe Borough Council (consolidated) Civil Enforcement Off-Street Parking Places Order 2020. In making these powers available, the regulation change intends to consolidate, under the 2004 Act, the existing civil enforcement regimes for bus lane contraventions (outside London currently under 2005 regulations made under the Transport Act 2000) together with parking contraventions (England-wide currently under 2007 regulations made under the 2004 Act). Creating a cohesive civil enforcement regime, removing numerous inconsistencies which inherently arose due to the disparate enabling legislation, providing a more efficient regime administration. Regulation changes are listed in the following schedule. In order to give full publicity to the amendment to regulation, this notice will be advertised in the Nottingham Post and site notices will be displayed at the relevant parking places.

This change of regulations will come into force within the existing Broxtowe Borough Council (consolidated) Civil Enforcement Off-Street Parking Places Order 2020 from Tuesday 31st May 2022.
